**BUSINESS**

Proposed Approval of Final Plat for Dutson Sub Division owned by Mel Dutson

The proposed approval of the final plat of Dutson Sub Division owned by Mel Dutson and Layne Duson, more specifically, phase 1, lots #1 and 2:


City Attorney Todd Anderson updated the Commission on the improvements for the Dutson Sub Division. Mr. Anderson reported that the only improvement missing was the sidewalks, and the property owner is asking that the lots may be sold and construction completed and then before occupancy the sidewalks will be built, which as Code Enforcement Officer Alan Riding stated is the City's preference. City Attorney Todd Anderson advised that the final plat be approved with the stipulation that the Restrictive Covenants be recorded. There was a discussion with the Commission regarding the Restrictive Covenants with City Attorney Todd Anderson. Commission Member Rand Crafts MOTIONED to approve the final plat for the Dutson Sub Division, Phase 1, lots 1 and 2 with the stipulated Restrictive Covenants to be recorded as part of the plat approval. Commission Member Alan Johnson SECONDED the motion. The motion passed with Commission Members Rand Crafts, Wes Duncan, Roger Zeeman and Alan Johnson voting in favor, and Commission Member Dick Jones, City Representative Kiley Chase and Commission Chairwoman Linda Sorensen being absent.

**OTHER BUSINESS**

Wes Duncan had previously expressed concern for the Auto Dismantling Business that had acquired a Conditional Use Permit and brought this issue up again. Code Enforcement Officer stated that the business was operating to code.
