Mayor Grant S. Nielson called the meeting to order at 6:30 p.m. Virginia Taylor, City Secretary, took minutes. Mayor Nielson read the following notice: NOTICE, is hereby given that the Delta City Council has scheduled a Public Hearing for the purpose of receiving public comment regarding a proposed amendment to the Annual Budget Fiscal Year 1985-1986 to appropriate \$6,000.00 to the Library Trust Fund, Monday, August 12, 1985, at the City Building, located at 76 North 200 West, Delta, Utah, which meeting shall begin promptly at 6:30 p.m.

Mayor Nielson requested City Manager Jim Allan address the issue of appropriation of \$6,000.00 to the Library Trust Fund.

City Manager Jim Allan said that Council Member Ruth Hansen has donated her wages for the past 2½ years in the amount of \$6,000.00 to the Library Fund. This has not been done on a monthly or yearly basis, therefore, there is no audit trail showing that money has been received and then donated.

City Manager Jim Allan asked if the \$6,000.00 would be allocated to the Library in the General Fund or would it be allocated to the Special Fund, which is a trust fund. Mr. Allan said that the way the budget is now set up, the funds in the General Fund are allocated to each one of the departments so if \$6,000.00 is going to be put into the Library, it should be done within the General Fund. Mr. Allan also said that in taking money out of the General Fund and putting it into the Special Fund, which is the trust fund for the Library, \$6,000.00 has to be taken from one of the departments within the General Fund.

Council Member Ruth Hansen instructed City Manager Jim Allan to figure out where the \$6,000.00 should come from and put it in the Library Fund. Mr. Allan proposed that a check be written for \$6,000.00 for the 1984-1985 Budget Year and to be included as a bona fide obligation for that fiscal year. Council Member Ruth Hansen suggested that a letter be written recognizing the \$6,000.00 as a donation from her to the Library.

Mayor Nielson then asked if there were any further questions or comments regarding the transfer of \$6,000.00 to the Library Trust. There being none, he declared the meeting adjourned at 6:45 p.m.
