

RESOLUTION NO. 83-94

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DELTA, UTAH EXPRESSING SUPPORT FOR CONSTRUCTION OF ADDITIONAL HEALTH CARE FACILITIES BY THE WEST MILLARD HOSPITAL DISTRICT WITHIN THE CITY OF DELTA.

WHEREAS, the City Council recognizes that the public benefit to Delta City residents and other residents of the West Millard Hospital District of maintaining adequate health care facilities in the Delta Area; and

WHEREAS, the City Council further recognizes need for additional health care facilities for the residents of Delta City due to the population increases, changes in the mode of delivery of health care services, regulations imposed by State and Federal authorities and general improvement of health care standards; and

WHEREAS, the West Millard Hospital District operates and maintains the West Millard Hospital District with the aid of management and other services from Intermountain Health Care; and

WHEREAS, West Millard Hospital District and Intermountain Health Care have determined that additional health care facilities need to be constructed to meet the present and future needs of the West Millard Area; and

WHEREAS, the City Council recognizes that significant benefits are received by residents of Delta and businesses located in Delta from the present West Millard Hospital and that these and other benefits will be realized by location of additional health care facilities in Delta City;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Delta, Utah:

1. The City Council hereby expresses support for the construction of additional health care facilities by enlargement of the present West Millard Hospital at the site of the present West Millard Hospital and encourages the West Millard Hospital District and Intermountain Health Care to examine carefully the feasibility of constructing improvements at that location.

2. Inasmuch as Delta City cannot provide financial aid to enlargement of the present hospital, the City Council further expresses that it is willing to lend support by aiding in the acquisition of land by negotiating with adjoining property owners and closure of such streets as may be necessary, reasonable and in the best interests of the residents of Delta to meet the site

requirements of expanded facilities at the location of the present West Millard Hospital District.

3. The City Council encourages citizen involvement in decisions regarding development of additional health care facilities by use of a citizens advisory board, public hearings and by other similar means.

4. The City Council further acknowledges that meaningful discussion between the City Council, the Millard County Commission and the West Millard Hospital District Administrative Control Board would facilitate development of such health care facilities and therefore encourages free exchange of information with the governing bodies of these entities.

5. This resolution shall become effective upon adoption.
