

RESOLUTION NO. 86-150

A RESOLUTION ESTABLISHING AND SETTING THE REAL AND PERSONAL PROPERTY MILL LEVY FOR FISCAL YEAR 1986-1987 FOR PROPERTY WITHIN THE JURISDICTION OF THE CITY OF DELTA, UTAH.

WHEREAS, the City Council of the City of Delta, Utah has adopted the Delta City budget for Fiscal Year 1986-1987, which budget contains the expenditures determined by the City Council as being necessary to maintain an acceptable level of municipal services and operations within the City of Delta; and

WHEREAS, the City Council has established a policy of developing a tax structure for the City of Delta that will properly balance the tax impact on property owners and attempt to establish more equitable forms of tax revenue; and

WHEREAS, the budget adopted by the City Council for Fiscal Year 1986-1987 provides for .001644 in the real and personal property certified tax levy;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Delta, Utah as follows:

1. Tax Levy. The real and personal property tax levy for such property within the jurisdiction of the City of Delta shall be .001644, as set forth in the Fiscal Year budget for Fiscal Year 1986-1987 heretofore adopted by the City Council.

2. Apportionment. The revenue acquired by the City of Delta from real and personal property taxes shall be apportioned as follows:

3. Effective Date. This resolution shall become effective upon adoption.

4. Severability. In the event that any provision of this resolution less than the entire resolution is held invalid by a court of competent jurisdiction, this resolution shall be deemed severable and such finding of invalidity shall not affect the remaining portions of this resolution.

5. Repeal of Conflicting Resolutions. To the extent that any resolutions or policies of the City of Delta conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provision hereof.
