

RESOLUTION NO. 86-155

A RESOLUTION AMENDING RESOLUTION NO. 86-149 AND THE BUDGET ADOPTED THEREBY TO PROVIDE FOR AMENDMENTS TO THE FISCAL YEAR 1986-87 BUDGET OF THE CITY OF DELTA AND THEREBY PROVIDING SPECIFIC AND SEPARATE BUDGETS FOR FEDERAL REVENUE SHARING TRUST FUNDS TO BE RECEIVED BY DELTA CITY DURING FISCAL YEAR 1986-87.

The City Council of the City of Delta, Utah, referred to in this resolution as the "City Council," hereby recites the following as the basis for adopting this resolution:

A. Resolution No. 86-149 adopted by the City Council adopted the budget for fiscal year 1986-87 for the City of Delta, Utah.

B. The City Council has determined, acting under the advice of the Mayor, Budget Officer, City Auditor and department heads that certain amendments to the Fiscal Year 1986-87 Budget are necessary to comply with the conditions for receipt of Federal Revenue Sharing Trust Funds by Delta City.

C. The expenditures and revenues contained in said amendment were the subject of the general budget hearings conducted by the City Council for adoption of the 1986-87 Fiscal Year Budget and it is the finding of the City Council that no further hearings or tentative budgets are necessary to comply with the provisions of the Utah Uniform Procedures Act. The purpose of this amendment is to comply with the conditions relevant to Federal Revenue Sharing Trust Funds.

D. The City Council conducted a public hearing on July 7, 1986 relative to the proposed revenues and expenditures involving Federal Revenue Sharing Trust Funds. The City Council received public comment at said public hearing and has determined to adopt the proposed Federal Revenue Sharing Trust Fund Budget.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Delta, Utah:

1. Federal Revenue Sharing Trust Fund Budget Adopted. The Fiscal Year 1986-87 Budget for the City of Delta, Utah as adopted in Resolution No. 86-149 is hereby amended as set out in the document attached hereto entitled "Federal Revenue Sharing Trust Fund" for Fiscal Year 1986-87 for the City of Delta, Utah. The budget attached hereto as Exhibit "A" is hereby adopted as a part of this resolution. The funds, budgets and appropriation as set forth in the Fiscal Year 1986-87 Budget, which already include the revenue sources and expenditures detailed in Exhibit

"A" hereto, shall be deemed to constitute the final budget for Fund 73 entitled "Federal Revenue Sharing Trust Fund" as specified in Exhibit "A" hereto.

2. Effective Date. This resolution shall become effective upon adoption.

3. Severability. In the event that any provision of this resolution less than the entire resolution is held invalid by a court of competent jurisdiction, this resolution shall be deemed severable and such finding of invalidity shall not affect the remaining portions of this resolution.

4. Repeal of Conflicting Resolutions. To the extent that any resolutions or policies of the City of Delta conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
