

RESOLUTION 87-167

A RESOLUTION AMENDING RESOLUTION 87-161 AND THE BUDGET ADOPTED THEREBY TO PROVIDE FOR AMENDMENTS TO THE FISCAL YEAR 1987-88 BUDGET OF THE CITY OF DELTA, UTAH.

The City Council of the City of Delta, Utah, referred to in this resolution as the "City Council" hereby recites the following as the basis for adopting this resolution:

WHEREAS, Resolution 87-161, adopted by the City Council adopted the budget for fiscal year 1987-88 for the City of Delta, Utah; and

WHEREAS, the City Council has determined, acting under the advice of the Mayor, City Auditor and department heads, that certain amendments to the fiscal year 1987-88 budget are necessary; and

WHEREAS, tentative amendments to the fiscal year 1987-88 have been duly prepared setting out the proposed changes to the fiscal year 1987-88 budget from that adopted in Resolution 87-161; and

WHEREAS, the City Council conducted a public hearing on Monday, August 17, 1987, after duly published notice of said hearing, for the time and in the manner provided by law to receive and consider public comment on the proposed amendments to the fiscal year 1987-88 budget; and

WHEREAS, after considering proposed amendments to the fiscal year 1987-88 budget and after hearing and considering the public comments thereon, the City Council has determined to adopt the proposed amendments set forth in the amended budget for fiscal year 1987-88 attached to this resolution.

NOW, THEREFORE, be it resolved by the City Council of the City of Delta, Utah:

1. Amendment to Fiscal Year 1987-88 Budget. The fiscal year 1987-88 budget for the City of Delta, Utah, as adopted in Resolution 87-161, is hereby amended as set out in the amended budget for fiscal year 1987-88 for the City of Delta, Utah, attached to this resolution and hereby adopted as part of this resolution. The funds, budgets and appropriations set forth in the attached document shall constitute the final budget for the City of Delta for fiscal year 1987-88 and are hereby adopted as such.

2. Effective Date. This resolution shall become effective upon adoption.

3. Severability. In the event that any provision of this resolution less than the entire resolution is held invalid by a court of competent jurisdiction, this resolution shall be deemed severable and such finding of invalidity shall not affect the remaining portions of this resolution.

4. Repeal of Conflicting Resolutions. To the extent that any resolutions or policies of the City of Delta conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
