RESOLUTION NO. 06-306

A RESOLUTION OF THE CITY OF DELTA, UTAH REPEALING RESOLUTION NO. 04-288 AND ADOPTING A NEW RESOLUTION ESTABLISHING A USER FEE FOR THE OPERATION, MAINTENANCE AND DELIVERY OF WATER TO DELTA CITY IRRIGATION SYSTEM USERS.

RECITALS

The City Council of the City of Delta, Utah, referred to herein as the "City Council," hereby recites the following as the basis for adopting this resolution.

A. The City Council heretofore established a ditch tax user fee and irrigation water rental fee whereby each user or class of users of such services were required to pay for the benefits received by them based on the cost of operation, maintenance and delivery of irrigation water.

B. The City Council has determined, through records and other information on file in the Delta City offices, that Delta City has experienced an increase in costs associated with the operation, maintenance and delivery of said irrigation water and desires to impose a new "user fee" to cover said costs and the administrative services associated therewith.

C. The City Council has further determined that it is in the best interest of its residents and will promote the general welfare of its residents to establish a new user fee.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Delta, Utah:

1. Repeal of Resolution No. 04-288. Resolution No. 04-288 establishing rate schedules for a ditch tax user fee and irrigation water rental fee is hereby repealed.

2. User Fee and Water Rental Fee Adopted. The fees charged to Delta City irrigation system users are hereby fixed in accordance with the following schedule:

<u>Subject</u>	<u>Service Charge</u>
a. User fee	\$70.00
b. Irrigation water rental fee	\$35.00/per acre foot

3. Payment. The annual payments provided for herein shall become due and payable on or before the 1st day of April, 2006 and a like sum shall be due and payable on or before the 1st day of April of each and every year thereafter until such time as said rate schedule is changed by the City Council.


4. Effective Date. This resolution shall become effective upon adoption.

5. Conflicting Actions. To the extent that this resolution conflicts with any prior resolution or other act of the Delta City Council of equal or lesser dignity, such other action shall be deemed amended to conform to and be made in accordance with the provisions of this resolution.
