RESOLUTION NO. 07-318

A RESOLUTION REQUESTING THE RECERTIFICATION OF THE  
DELTA CITY MUNICIPAL JUSTICE COURT.

The City Council of the City of Delta, Utah, referred to in this Resolution as the "City Council," hereby recites the following as the basis for adopting this Resolution:

WHEREAS, the provisions of U.C.A. 78-5-139(2) require that Justice Courts be recertified at the end of each four (4) year term; and

WHEREAS, the term of the present Court shall expire on or about February 6, 2008; and

WHEREAS, the members of the City Council have received an Opinion Letter from Kaela P. Jackson, the Delta City Attorney, which sets forth the requirements for the operation of the Justice Court and the feasibility of continuing to maintain such Court; and

WHEREAS, the members of the City Council have determined that it is in the best interest of Delta City to continue to provide for a Municipal Justice Court;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Delta, Utah:

Section 1. Request for Recertification. The City Council hereby requests recertification of the Delta City Justice Court by the Justice Court Standards Committee and the Utah Judicial Council.

Section 2. Compliance with Judicial Council Requirements. The City Council of the City of Delta hereby affirms their willingness to continue to meet all requirements set forth by the Judicial Council for continued operation of the Delta City Justice Court for the next four (4) year term of said Court, except as to any requirements waived by the Utah Judicial Council.

Section 3. Effective Date. This resolution shall become effective upon adoption.

Section 4. Repeal of Conflicting Resolutions. To the extent that any resolutions or policies of the City of Delta conflict with

the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
