

RESOLUTION NO. 11-339

A RESOLUTION OF THE COUNCIL OF THE CITY OF DELTA, STATE OF UTAH, REQUESTING THE RECERTIFICATION OF THE DELTA CITY MUNICIPAL JUSTICE COURT.

The City Council of the City of Delta, Utah, hereby recites the following as the basis for adopting the Resolution:

WHEREAS, the provisions of Utah Code Ann. § 78A-7-103 requires that justice courts be recertified at the end of each four (4) year term; and

WHEREAS, the current term of the Delta City Justice Court shall expire on or about February 6, 2011; and

WHEREAS, the members of the City Council have received an Opinion Letter from Todd F. Anderson, the Delta City Attorney, which sets forth the requirements for the operation of the Delta City Justice Court and the feasibility of continuing to maintain that court; and

WHEREAS, the members of the City Council have determined that it is in the best interest of Delta City to Continue to provide for the Delta City Municipal Justice Court;

NOW, THEREFORE, be it hereby RESOLVED by the Council of the City of Delta, State of Utah THAT:

**Section 1. Request for Recertification.** The City Council hereby requests recertification of the Delta City Justice Court by the Justice Court Standards Committee of the Utah Judicial Counsel.

**Section 2. Compliance with Judicial Council Requirements.** The City Council of the City of Delta hereby affirms their willingness to continue to meet all requirements set forth by the Utah State Legislature and the Utah Judicial Council for continued operation of the Delta City Justice Court for the next four (4) year term of said Court, except as to any requirements waived by the Utah Judicial Council.

**Section 3. Effective Date.** This resolution shall take effect immediately upon adoption, as authorized by section Utah Code Ann. § 10-3-719 of the Utah Code Annotated.

**Section 4. Repeal of Conflicting Resolutions.** To the extent that any resolutions or policies of the City of Delta conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
